transportation study (if applicable).

Final Submittal - submit Pdf of plan set, 3 paper copies of Stamped Plans

All plans submitted must include a coversheet with a complete project description and contact information.

All plans for additions, build outs, tenant changes, and renovations must show the project location in relation to the entire existing floor/structure of the building in which said construction is proposed.

A complete set of approved plans SHALL BE MAINTAINED ON THE CONSTRUCTION SITE for inspections 24/7.

All revisions to plans shall be approved prior to the start of the said construction.
