## Minutes Dawson County Board of Tax Assessors Tuesday, November 14, 2023

The Board of Tax Assessors met on Tuesday, November 14, 2023, at 8:30 a.m. with the following persons present:

Tom Camp, Vice Chairperson : Sam Gutherie, Member Jim Perdue, Member Roxanne Howard, Member Elaine Garrett, Chief Appraiser

Vice Chairperson Camp called the meeting to order.

Vice Chairperson Camp called for the approval of the October 2023 meeting minutes. (Document #1)

 Mr. Gutherie made the motion to approve the October 2023 meeting minutes, seconded by Ms. Howard. All Members voted unanimously for approval.

Vice Chairperson Camp called for the digest changes: (Document #2)

 Mr. Gutherie made the motion to accept all digest changes, seconded by Ms. Howard. All members voted unanimously for approval.

The performance report for October 2023 was presented. (Document #3)

Vice Chairperson Camp called for an appeal update.

Ms. Garrett stated that as of today the office has resolved 2,195 appeals. Currently, there are 142
appeals having received a 30-day notice, 37 active appeals, and 98 waiting for the Board of
Equalization.

Vice Chairperson Camp called for Old Business

No old business presented.

Vice Chairperson Hause called for New Business.

- Ms. Garrett presented a request to approve the use of NADA (National Automobile Dealers Association) as a means to determine values on Mobile Homes. Mr. Gutherie made a motion, with a second by Ms. Howard to approve the use of the NADA values for 2024. All members voted in favor of the motion. (Document #4)
- Ms. Garrett presented the Board with a request to use ABOS (Anderson Bugg Outboard Services) as a means to value marine equipment for 2024. Mr. Gutherie made a motion, with a second by Ms. Howard to approve the use of the ABOS values for 2024. All members voted in favor of the motion. (Document #5)
- Ms. Garrett presented the Board with a late appeal for Personal Property Account # 36131. The
  deadline to file an appeal on the 30-day notice was 10-29-2023. The owner filed an appeal on 118-2023. Mr. Gutherie made a motion to deny the appeal due to the late filing, with a second by
  Ms. Howard. All members voted unanimously to deny the appeal. (Document #6)
- Ms. Garrett presented the Board with the Georgia Archives Record Retention Schedule. Mr.
  Gutherie made a motion to use the schedule in the office concerning the retention of documents,
  with a second by Ms. Howard. All members voted in favor of the motion. (Document #7)
- Ms. Garrett shared information with the Board concerning Policy 11 of the Dawson County Board
  of Assessors Policy and Procedure Manual, which sets the date for all supporting documentation
  related to Specialized Exemptions to be submitted by April 1 of each year. Mr. Perdue made a
  motion to extend the date for submitting documentation to coincide with the Federal Tax deadline
  of April 15 if the citizen has completed the application by the April 1 deadline given by the State
  as the deadline for filing Exemption Applications. Ms. Howard seconded the motion and all
  members voted in favor of the motion. (Document #8)
