Chairperson Hause called the meeting to order.

Chairperson Hause called for a motion to approve the agenda for the March 14, 2023 meeting.

• Ms. Howard made the motion to approve the agenda, seconded by Mr. Gutherie. All members voted unanimously for approval

Chairperson Hause called for the approval of the January 10, 2023, meeting minutes. (Document #1)
